Mono Technology Public Company Limited (the “Company”) would like to submit the copy of financial report and financial statements for the second quarter of 2015 (ended June 30, 2015) reviewed by the auditor and the meeting of the Audit Committee No. 3/2015 held on August 5, 2015. These financial report and financial statements were also approved by the meeting of the Board of Directors No. 3/2015 held on August 5, 2015. ## 1. Total Revenues

For the second quarter of 2015, the total revenues of the Company and subsidiaries amounted to 474.71 million Baht, compared to 371.95 million Baht of the second quarter of 2014, increasing by 102.76 million Baht or 27.63 percent.

The MVAS revenue for the second quarter of 2015 was 239.76 million Baht, compared to 265.26 million Baht of the second quarter of 2014, decreasing by 25.50 million Baht or 9.61 percent.

The advertising revenue for the second quarter of 2015 was 197.14 million Baht, compared to 58.77 million Baht of the second quarter of 2014, increasing by 138.37 million Baht or 235.44 percent due to the apparent growth of digital TV business which successfully operates MONO29 channel.

## 2. Net profit

For the second quarter of 2015, the net loss before taxes and , expenditures and write off non-performing assets from the organizational restructure in the second quarter of 2015 totaled 119.41 million Baht, compared to 16.33 million Baht of the second quarter of 2014, increasing by 103.08 million Baht or 631.23 percent due to the recognition on marketing cost and content-related expenses this year, while they were recognized initially in small amount last year. Besides, the expenditures and write off non-performing assets of the Company and subsidiaries incurred in this particular quarter totaled 88.65 million Baht.
