Mono Technology Public Company Limited (the “Company”) would like to submit the copy of financial report and financial statements for the third quarter of 2015 (ended September 30, 2015) reviewed by the auditor and the meeting of the Audit Committee No. 4/2015 held on November 13, 2015. These financial report and financial statements were also approved by the meeting of the Board of Directors No. 4/2015 held on November 13, 2015. Details of operating results can be summarized as follows:

1. Total Revenues

For the third quarter of 2015, the total revenues of the Company and subsidiaries amounted to 464.57 million Baht, compared to 427.08 million Baht of the third quarter of 2014, increasing by 37.49 million Baht or 8.78 percent.

The MVAS revenue for the third quarter of 2015 was 222.18 million Baht, compared to 300.47 million Baht of the third quarter of 2014, decreasing by 78.29 million Baht or 26.06 percent.

The advertising revenue for the third quarter of 2015 was 190.08 million Baht, compared to 80.98 million Baht of the third quarter of 2014, increasing by 109.10 million Baht or 134.72 percent due to the apparent growth of digital TV business which successfully operates MONO29 channel.

2. Net profit

For the third quarter of 2015, the net loss in the third quarter of 2015 totaled 96.12 million Baht, compared to 18.52 million Baht net profit of the third quarter of 2014, the net loss increased by 114.64 million Baht or 619.01 percent due to the recognition on marketing cost and the increase in content-related expenses. Compare to the net loss in the second quarter of 2015 totaled 193.87 million Baht, the net loss decreased 97.75 million Baht or 50.42 percent. This is due to the recognition on expenditures and write off non-performing assets of the Company and subsidiaries incurred in this particular quarter totaled 88.65 million Baht.
